

Student Service Hours Reporting: Quick Start Guide

The Pro Bono & Community Service Initiative has adopted a new tool within the Vincent platform powered by 12Twenty that will make reporting your service hours even easier! In just a few easy steps this quick start guide will walk you through how to create a new experience, submit your service hours, and track your completed service opportunities.
