THE OPIOID CRISIS: WHERE DO WE GO FROM HERE?

The darkest days of America's opioid crisis may be behind us. For the first time in four years, American life spans are increasing—apart from the effects of Covid-19—as opioid deaths decline. We have, however, a long way to go, both to heal sorely damaged communities and to learn from the catastrophe. At the 26th Clifford Symposium, some of America's leading experts will consider the legal and public health implications of the scourge and our responses to it. The symposium will begin with reports from the front lines of the opioid litigation by those intimately involved in the matter. It will then turn to consideration of the procedural mechanism that has framed our primary response to the crisis—multi-district litigation. Symposium faculty will then discuss some of the substantive legal tools being used or considered to address the problem and those who caused it, most particularly tort claims (especially public nuisance) and criminal sanctions. The symposium will then examine a range of public health initiatives to assist in the nation's recovery. Finally, a number of prior litigation experiences (especially the tobacco imbroglio) will be examined as signposts to where our responses may lead us.

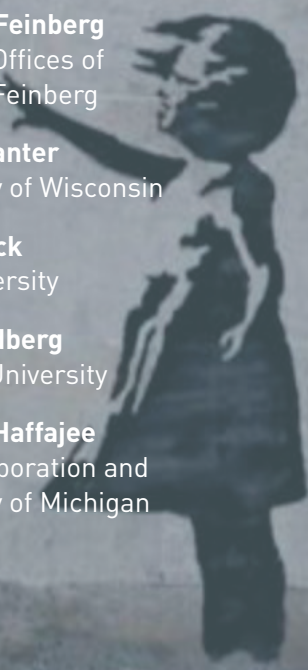
