On February 20th, Ellen Miller, DMC Practitioner in Residence, will present her recent research on the experiences of new neighbors in accessing legal services in Chicago. Over the past few months, Ellen and her team have conducted focus groups and interviews with migrants and asylum seekers who arrived from the U.S. southern border between Fall 2022 and Fall 2024 and accessed legal services in Chicago.

This presentation will showcase key findings from these participatory evaluations. The overall goal of the project is to elevate the voices of migrants as key community members and encourage service providers to incorporate inclusive programmatic decision making processes.

Learn about challenges faced in accessing immigration legal services

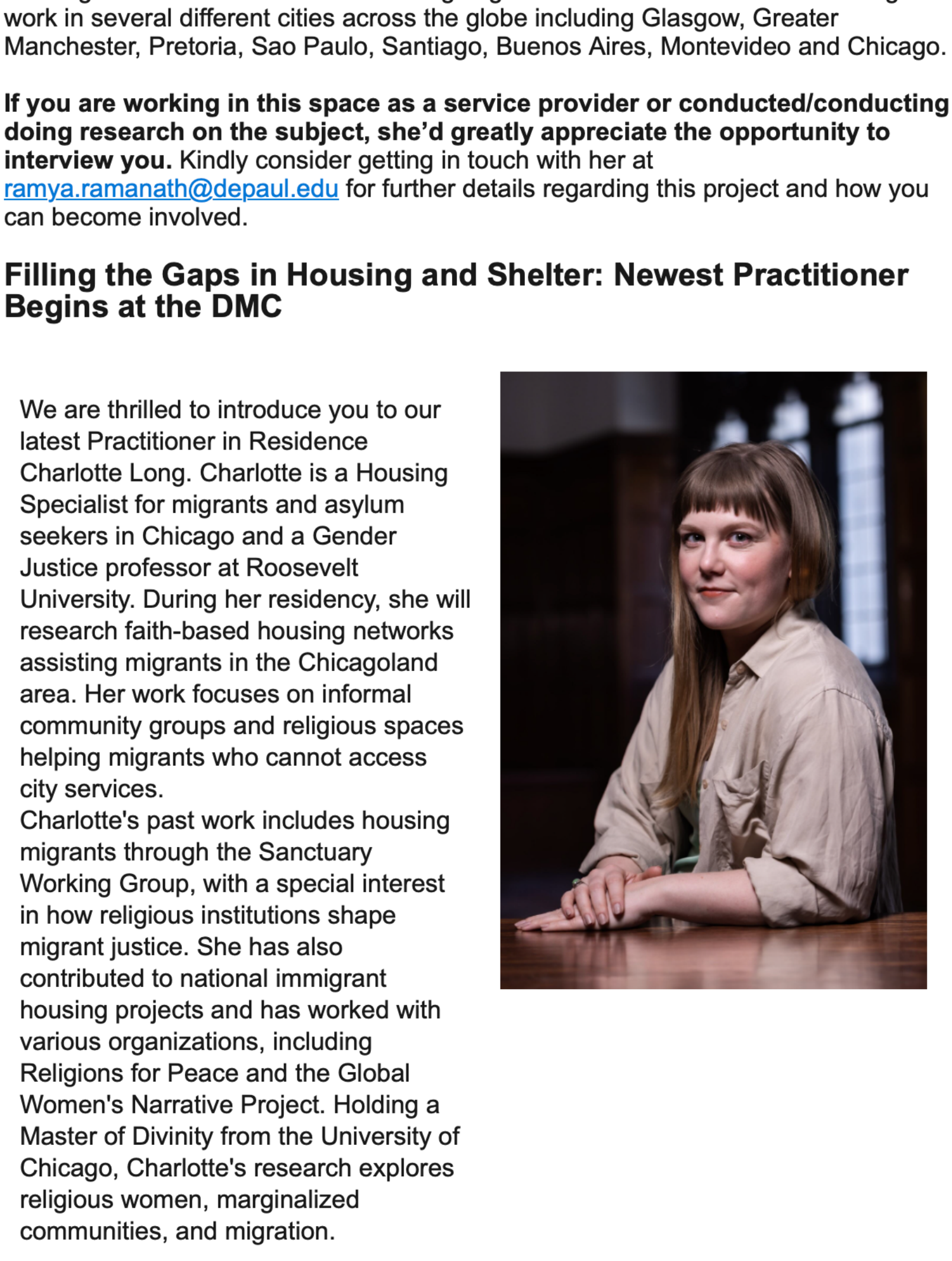

Call To Participate in Global Homelessness Research

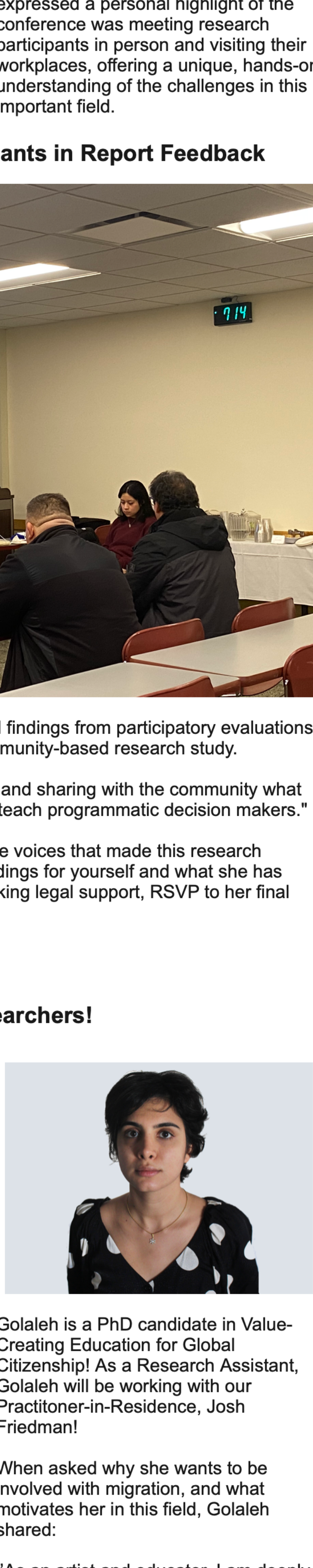

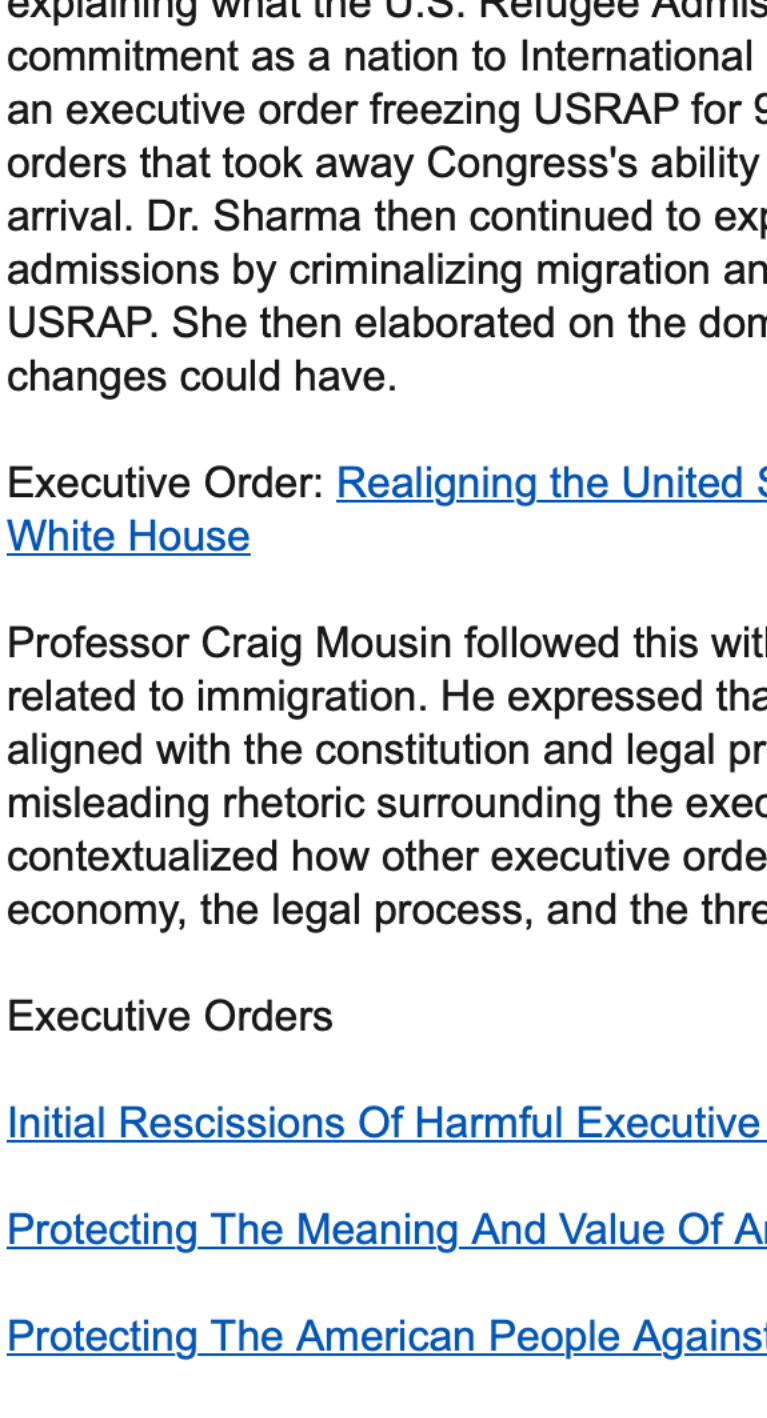
Filling the Gaps in Housing and Shelter: Newest Practitioner Begins at the DMC

We are thrilled to introduce you to our latest Practitioner in Residence Charlotte Long. Charlotte is a Housing Specialist for migrants and asylum seekers in Chicago and a Gender Justice professor at Roosevelt University. During her residency, she will research faith-based housing networks assisting migrants in the Chicago and area. Her work focuses on informal community groups and religious spaces helping migrants who cannot access city services. Charlotte's past work includes housing migrants through the Sanctuary Working Group, with a special interest in how religious institutions shape migrant justice. She has also contributed to national immigrant housing projects and has worked with various organizations, including Religions for Peace and the Global Women's Narrative Project. Holding a Master of Divinity from the University of Chicago, Charlotte's research explores religious women, marginalized communities, and migration.

Dr. Ramya Ramanath Presents at International Journal on Homelessness Conference in Chile



At the International Journal on Homelessness Conference in Santiago, Chile (January 20-22, 2025), Solutions Lab Grantee Dr. Ramya Ramanath presented their paper titled "Dynamics of Care and Control that Precipitate (and Preclude) Homelessness Among Migrants." The presentation explored how various actors, such as NGOs, community networks, private landlords, and broader structural issues like housing markets and migrant reception systems, impact housing outcomes for those forcibly displaced. At the Conference Dr. Ramanath also shared her ongoing research globally. The talk highlighted both the challenges and opportunities in supporting migrant housing stability. Dr. Ramanath expressed a personal highlight of the conference was meeting research participants in person and visiting their workplaces, offering a unique, hands-on understanding of the challenges in this important field.

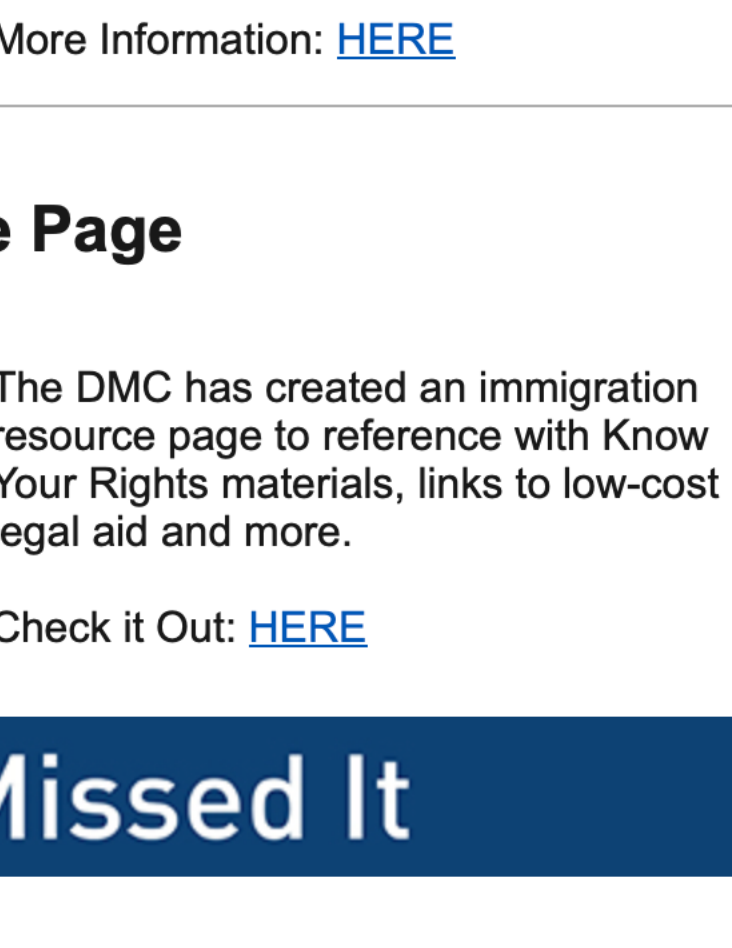
Meet the New DMC Student Researchers!

When asked why she wants to be involved with migration, and what motivates her in this field, Golaleh shared:

My own work often explores themes of translation—what it means to translate and adapt when far removed from the geography of one's origins. This personal lens fuels my commitment to creating spaces where migration is not only acknowledged but celebrated as a source of wisdom, courage, and resilience. I see this field as an opportunity to contribute to the global dialogue on how we can cultivate empathy, compassion, and inclusivity in the face of ongoing displacement and globalization. Working in this space aligns with my belief in education as a transformative force for individuals and communities alike."

Asylum Through the Looking Glass: Executive Orders and the Future of Refuge

On February 12th, the DMC kicked off their series responding to the immediate changes in the migration landscape. This first event examined recent U.S. Executive Orders affecting immigration and refugee policies. Professor Sharma opened by explaining what the U.S. Refugee Admission Program (USRAP) is and our commitment as a nation to International Humanitarian Law. President Trump signed an executive order freezing USRAP for 90 days and this was followed by a set of orders that took away Congress's ability to regulate refugee and asylum seeker's arrival. Dr. Sharma then continued to explain how these orders change refugee admissions by criminalizing migration and institutional subverting the purpose of USRAP. She then elaborated on the domestic and international impact these changes could have.

Professor Craig Mousin followed this with an in depth look at other Executive Orders related to immigration. He expressed that some of these executive orders are not aligned with the constitution and legal processes. He also highlighted dangerous and misleading rhetoric surrounding the executive orders. Dr. Mousin then contextualized how other executive orders will have an impact on immigration, the economy, the legal process, and the threats to our morals as a people.

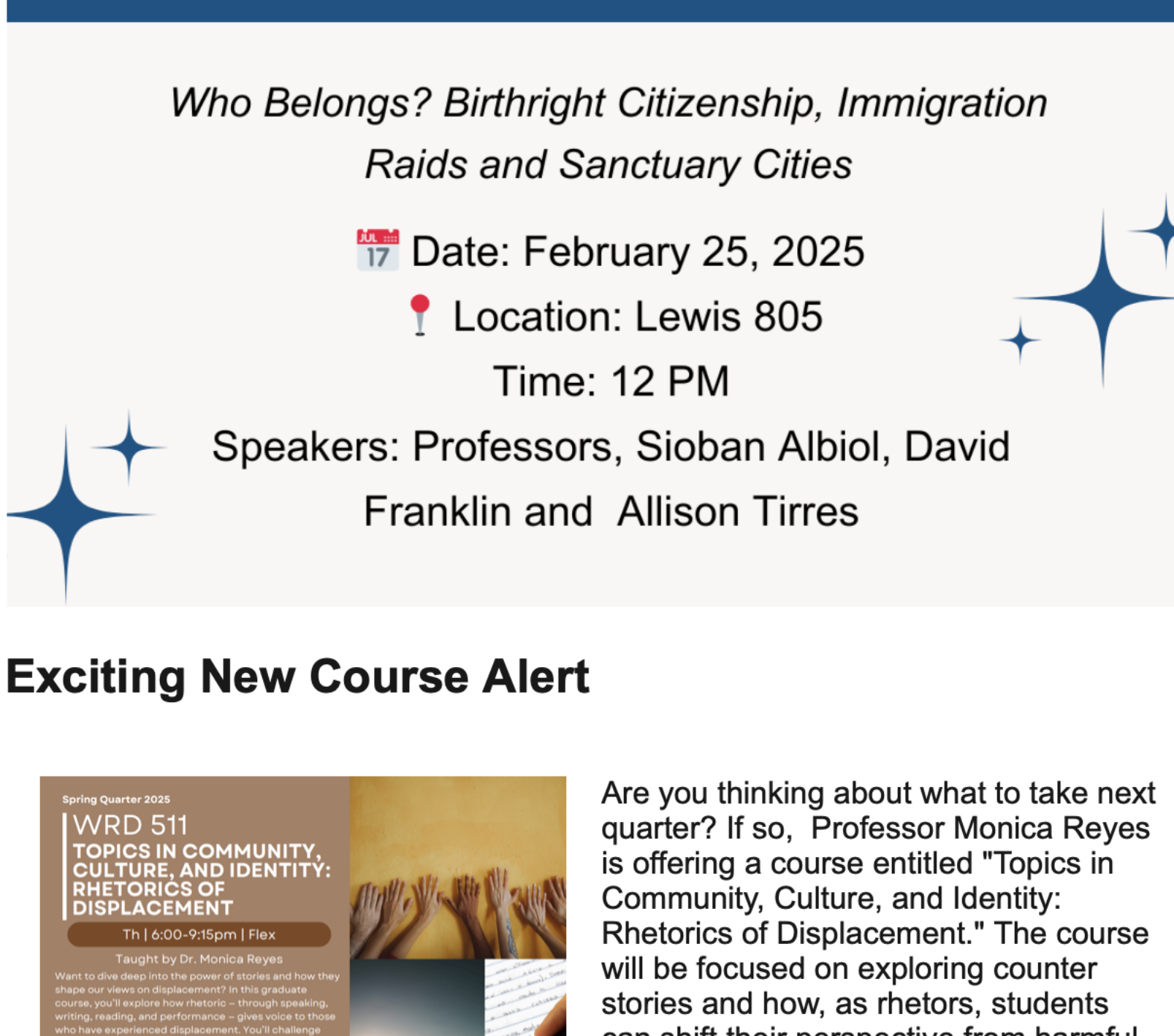

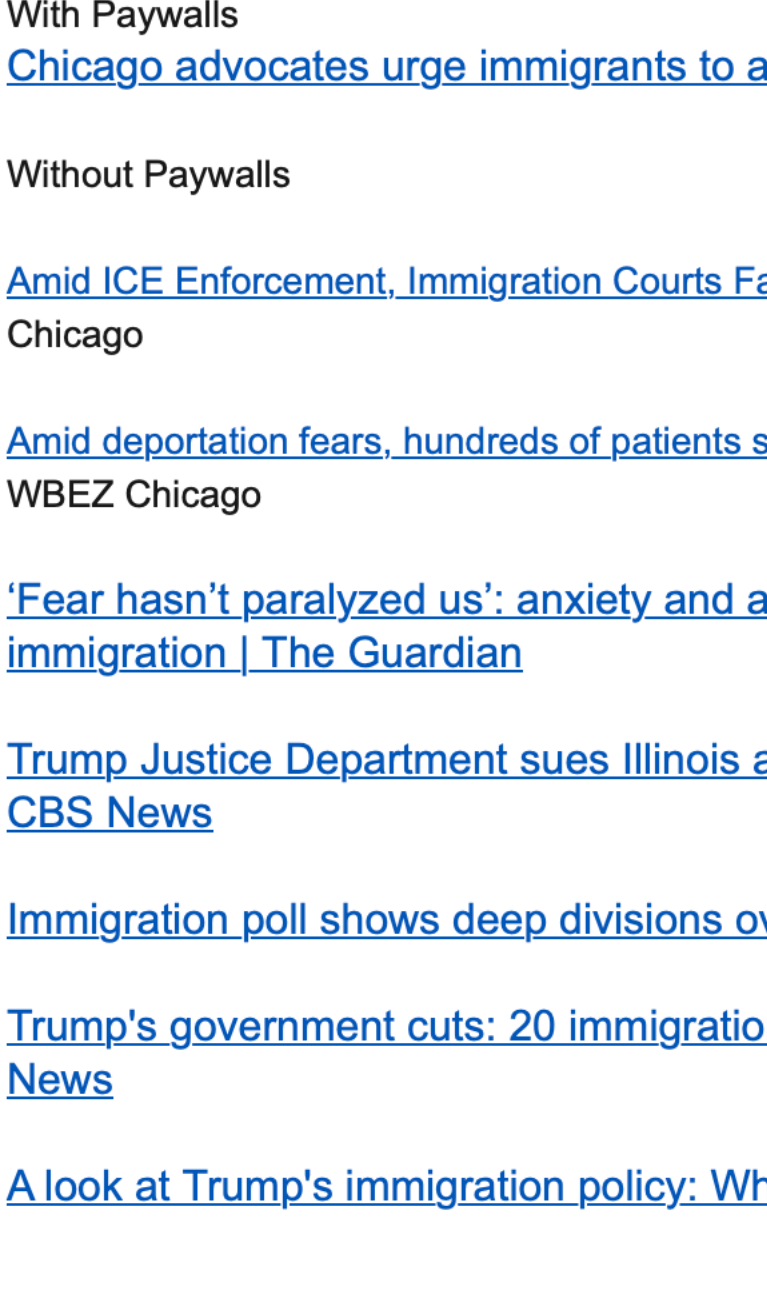

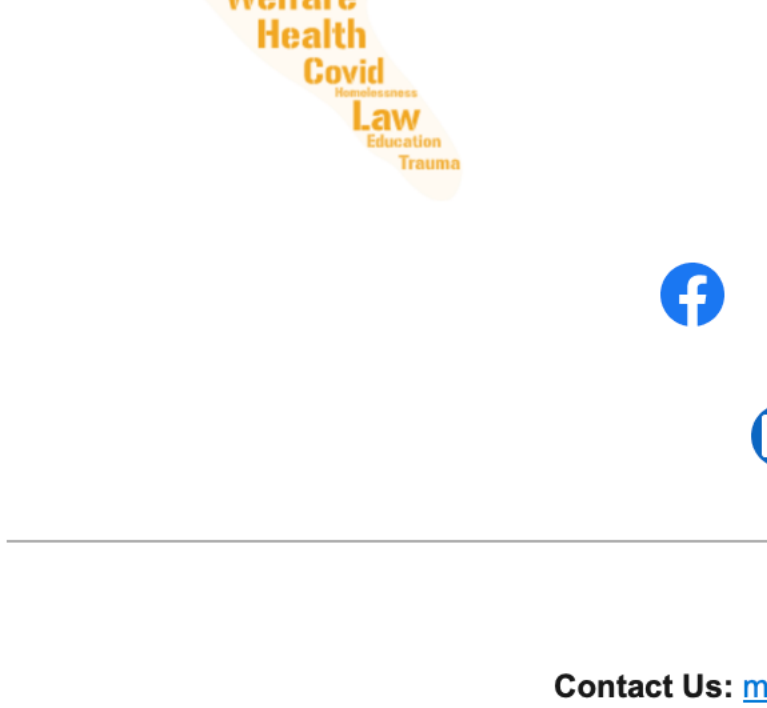
Exciting New Course Alert
