

### DMC Hosts Panel on Chicago Response to Recent Arrivals

On Tuesday, January 30th, the DePaul Migration Collaborative (DMC) hosted a thought-provoking panel addressing the multifaceted issues surrounding recent migrants in Chicago engaging over 50 participants. The panelists included DMC Practitioners in Residence, Rob Paral of Rob Paral and Associates, a policy consultant and Dr. Elizabeth Kennedy, a Country Conditions Expert and Social Scientist. They were accompanied by Laura Rodríguez Presa from the Chicago Tribune, and Breandán Magee, Senior Director of Programs for the Illinois Coalition for Immigrant and Refugee Rights (ICIRR). The insightful conversation was moderated by Dr. Jesse Mumm of DePaul's Latin American and Latino Studies Program.

Each panelist delivered a concise presentation, covering their involvement with recent arrivals. The event explored reasons migrants may flee their home countries, migrant experiences at the US-Mexico border, the journey of migrants being bussed to northern cities, and the unique situation of Ukrainian refugees in the Chicago area. Tensions between migrants and host communities were also examined, especially regarding available housing and shelter. Another theme included in the discussion was the examination of current federal and state laws and responses to the migrant situation. The panel also demonstrated the indispensable role of nonprofits in responding to these challenges, providing essential advocacy, resources, and legal services. This event not only offered valuable insights into the current migration events but also fostered an open dialogue on the legal aspects, enhancing participants' understanding of the broader context.





The DePaul Migration Collaborative (DMC) recently organized a training session for faculty members from across the Chicago area on 1/25, led by Dr. Elizabeth Kennedy, Practitioner in Residence with the DMC. Dr. Kennedy, recognized for her expertise in the country conditions of Honduras, Guatemala, and El Salvador, comprehensively covered the role of country conditions experts and their significance in the asylum process.

The training was especially valuable for faculty who want to assist those seeking asylum but did not have knowledge of the asylum court system. Faculty attended from DePaul, Northwestern, and UIC. Dr. Kennedy detailed how to connect with an asylum case, how to turn research into country condition reports, and what to expect when testifying in the courtroom.

This interactive session not only equipped faculty members with practical knowledge but also fostered a sense of community among the participants, reinforcing the DMC's commitment to addressing migration challenges by connecting with service opportunities.
