**CV:** Professor of law at DePaul since 1978; Director DePaul University/University College Dublin Cooperative Program; Co-Director of the International Aviation Law Institute; Served as Associate Dean for nine years and as Acting Dean; Collaborated with the Administrative Office of the Illinois Courts for 20 years conducting seminars on tort law for Illinois Judges

### ADVICE FOR 1L?

My advice is to spend the summer reading good literature. You will spend most of the next three or four years reading judicial opinions, statutes, and law review articles. Take this time to read some good books. They are both enjoyable and will help you prepare for the writing that you will do in law school. Many of you did not do too much writing as undergraduates. My most vivid memories are of my classmates. You will spend about 15 hours a week in class while in law school. 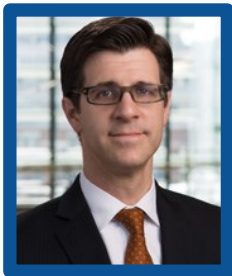
### FUN FACT?

## MATTHEW LINDSAY 1L CONSTITUTIONAL LAW

**COURSES:** American Legal History; Immigration Law

**CV:** Visiting professor from the University of Baltimore; Served for two years as a Climenko Fellow and Lecturer in Law at Harvard Law School; Clerked for Judge Louis H. Pollak of the Eastern District of Pennsylvania; Awarded a fellowship by the American Academy of Arts and Sciences; Practiced federal administrative law and patent litigation at Foley Hoag LLP; Writes in the areas of legal history, immigration, and civil rights; Articles have appeared in *Harvard Civil Rights-Civil Liberties Law Review*, *University of Cincinnati Law Review*, *Yale Journal of Law & Humanities*, and *Law & Social Inquiry*; Currently completing a doctoral dissertation in United States legal history on the historical origins and development of the federal immigration power

### ADVICE FOR 1L?

It would be difficult to design a more effective breeding ground for intellectual insecurity than the first year of law school. The course material is unfamiliar and difficult; the heavy work load virtually ensures that you're often underslept; and both the daily drama of the Socratic method and the looming grading curve create an inherently competitive atmosphere. Faced with all that, it's easy to feel overmatched, or even like a fraud—that the professor or your classmates are talking over your head, that you're somehow missing all the “important” stuff even though you're doing the reading, or that the school is demanding the impossible. I remember feeling all those things. Recognizing that this kind of insecurity is not only common, but a normal, predictable part of the first-year experience (even among classmates who seem to exude supreme confidence) will help you to put it in its place, and to hold in check the inevitable sense of inadequacy or of being overwhelmed.

### MOST VIVID LAW SCHOOL MEMORY?

I walked into my first law school class ever without having completed a single sentence of the assigned reading, expecting nothing more than a general introduction to the subject (Civil Procedure) and a breezy tour through the syllabus. When the professor—a renowned senior teacher and scholar with a serious, imposing countenance—strode into the room, set his materials down on the podium and, without looking up, commanded in his thick Bronx accent, “Ms. Jackson, tell me what happened that gave rise to the case that you read about for today,” a flush of terror rushed through my body. I spent the next fifteen minutes in a state of dread, my heart racing and sweat beading on my forehead, as Ms. Jackson staged a virtuoso performance, recounting the facts with clarity and precision, and expertly responding to every one of the professor's interjections. Fate spared me that day, but I took the lesson to heart, and for the remainder of law school (almost) never repeated my early mistake. Not least, that professor eventually became a valued friend and mentor with whom, 20 years later, I remain in regular contact.

I play the guitar so badly that I can virtually compel my otherwise obstinate children to get ready for bed merely by glancing in the instrument's direction.

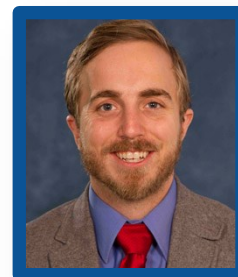
### MY SPARE TIME?

## MARK WEBER 1L TORTS

**COURSES:** Civil Procedure; Civil Rights; Complex Civil Litigation; Constitutional Process; Disability Law; Federal Courts; Remedies; Special Education Law; Torts

**CV:** Professional interests are disability rights and complex tort litigation; Author of *Disability Harassment, Understanding Disability Law, Special Education Law Cases and Material*, and *Special Education Law and Litigation Treatise*; Presented testimony on the implementation of the ADA to the U.S. Civil Rights Commission, and is active in community service and legislative initiatives on disability matters; Began his career as a staff attorney at the Legal Assistance Foundation of Chicago and then worked as a clinical fellow at University of Chicago Law School; Served as associate dean and acting dean of the DePaul's College of Law; Received the College of Law Outstanding Teaching Award, the DePaul University Excellence in Public Service Award, the College of Law Excellence in Scholarship Award, the DePaul Spirit of Inquiry Award, and the Center for Disability and Elder Law Distinguished Service Award; Named Vincent dePaul Professor of Law in 2004

### ADVICE FOR 1L?

Be as engaged with what you are studying as you possibly can, both during class time and when preparing for class. React to what you read and hear and keep asking whether it makes sense and why. In my experience, the degree of engagement with the material is the best predictor of how well students master the subject matter. Also, be sure to get enough sleep!

### MOST VIVID LAW SCHOOL MEMORY?

Participating in my law school's legal clinic and working part time at New Haven Legal Assistance were memorable experiences for me. The law school clinic provided legal representation to patients at a mental hospital, and gave me the opportunity to present motion arguments in federal court on two cases concerning civil commitment standards. As an intern at Legal Assistance in third year, I was in court nearly every week doing eviction defense and other cases. The experiences were opportunities to learn how to be a lawyer while helping people who needed representation.

### FAVORITE BOOK?

I'm afraid I don't have a single favorite book, but one I am currently reading and that I'd recommend is *The Evangelicals: The Struggle to Shape America* by Frances Fitzgerald. It covers the history of the Evangelical movement and its influence on American political developments, and does a remarkable job on both theology and politics.

I'm not all that big on fancy food, and tend instead to like local hole-in-the-wall places. One that I would recommend is Svea, a Swedish breakfast and lunch spot in Andersonville.

In the 1980's I was a supervising attorney at the legal aid clinic at the University of Chicago law school. One of my students was future FBI Director James Comey.

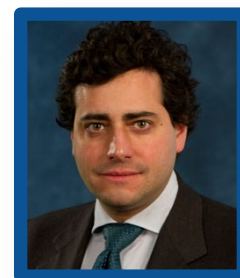
### MY SPARE TIME?
