If you answered "yes" to any question(s) in the character and fitness section on page 2 of the application, you must submit written explanation(s). Once your file is complete you should receive a decision in approximately 2 to 3 weeks.

A personal statement not exceeding two pages is required and must be submitted with your application. Two letters of recommendation are required of all applicants. A current resume is required and should not exceed two pages. Please see the instructions for additional information.
